Deputy Director Crawford presented the second quarter investment report.

Second Quarter Fiscal 2022/2023 Investment Report

The State of Michigan Public Act 213 of 2007 requires the City's investment officer to provide a written report quarterly to the governing body concerning the investment of all funds of the City that fall under Public Act 20. Public Act 20 governs how non-pension and non-OPEB funds can be invested. The attached report

details the cash and investments (citywide for all funds) held by the City on December 31, 2022. The report includes a description of each investment by type, market and book values, current and yield to maturity interest rates and the number of days to maturity.

The second quarter investment report shows total citywide cash and investments of \$40,946,618 (market value) including cash in the operating account of \$3,071,581 (excluding outstanding checks and other adjustments), short-term investments in Investment Pools of \$3,520,194, money market of \$12,053,132, commercial paper of \$14,938,144 and long-term investments total \$7,363,567. The City has maximized investment return on short-term cash by utilizing Investment Pools and took advantage of a special money market rate. During this quarter the majority of the funds have been invested in a special money market, a new investment pool and commercial paper as they provides the greatest yield and security while interest rates continue to rise due to inflation concerns. Longer-term investments purchased in previous quarters saw a nice decrease in the unrealized losses as fixed income securities saw a decrease in values as equities rebounded. Investment income for the months of October through December 2022 included interest income of \$161,873 and unrealized gains on investments of \$201,223.

During the second quarter actual investment returns significantly increased with the rise in interest rates (approximately 3.4%) which includes the reversal of prior quarters unrealized losses of existing longer-term investments. The increase in actual returns is expected to continue as the Feds have warned of additional interest rate increases in the coming quarter along with the reversal of unrealized losses on longer-term investment as they get closer to maturity.

(AGENDA ITEM #15C) Quarterly Financial Report for period ending 12/31/2022

Finance Director Crawford presented the second quarter financial report.

GENERAL FUND

REVENUES

Total revenues for the second quarter total approximately \$18.3 million, representing approximately 74% of the annual budget. Overall revenues are on track with budget with the following items of note:

- Property Tax Revenue – City property tax levies are billed July 1 and payable in full without penalty by August 31, 2022. As of the end of the second quarter approximately 96% of the taxes billed had been paid. Any unpaid real property taxes will be purchased from the City by Oakland County in May 2023. Property tax revenue is the primary reason the overall revenues are at 74% to date.
- Intergovernmental Revenue (State Revenue Sharing) – The City receives six bi-monthly payments annually for state-shared revenue. The second quarter report reflects two fiscal 2023 payments as the August 31, 2022, payment by statute is included as part of the June 30, 2022 revenues. The City will receive payments on February 28, April 30, June 30 and August 31 (2023) related to the current fiscal year. The estimated annual revenue included in the budget totals \$4,141,498.
- Fines and forfeiture revenue received from the 45th District Court is budgeted for a total of \$1,300,000 of which \$468,863 or 36% was received in this second quarter. Overall court revenue continues to be less than prior year and less than budget due the reduced number of tickets written by all communities. The court has done a good job reducing their costs to offset some of the lost revenue, but the City's net contribution continues to increase. The revenue received is used to offset a portion of the court's operating costs. Finance will continue to monitor both the court revenue and expenditure budgets and amended as necessary.
- Federal grants revenue is budgeted at \$1.51 million and includes \$560,000 for police body cams and \$950,000 from the second and final ARPA grant payment. No revenue had been recognized during the second quarter.

- Cable franchise fee revenue is budgeted at \$480,000 and includes only the first quarter payments of \$114,980. Cable revenue is received approximately 30 days after the end of each quarter with the second quarter payment being received in January 2023.

EXPENDITURES

Total expenditures for the second quarter total approximately \$14.6 million, representing approximately 43% of the annual budget. Overall departmental expenditure budgets are on track with the following items of note (departments over 50%):

- Defined benefit pension contributions for the Employees Retirement System are at 68% through the second quarter and impacted any department who has employees eligible for that system. The contribution rate will be decreased for future quarters to get the expenditure back to the budgeted amounts along with adjustments recommended in the second quarter budget amendment.
- The Elections and City Clerk's Departments are at 69% and 55%, respectively due to the two budgeted elections took place during the first two quarters of the year. New unfunded election mandates have increased department costs and amendments are recommended for the second quarter.
- The Finance & Admin. Services Department is at 70% of their budget due to the significant number of employees included in the defined benefit pension plan (see bullet number 1 above). The overall budget is in line with the current annual projections.
- The recreation departments including Outdoor Activities (55%) and Swimming Pool (71%) are currently over the 50% guideline primarily due to their costs being seasonal in nature as a significant part of their budget includes summer programming. The overall budget is in line with the current annual projections.

The current amended budget includes roll over budget amendment from fiscal year 2021/22 of \$450,000, an increase for prosecuting attorney fees of \$15,000 and the purchase of pistols for public safety of \$54,578 for a total use of fund balance of \$519,578. Overall, the General Fund operations are in line with the annual budget. The projected fund balance remains at the targeted level of 17% of annual expenditures.

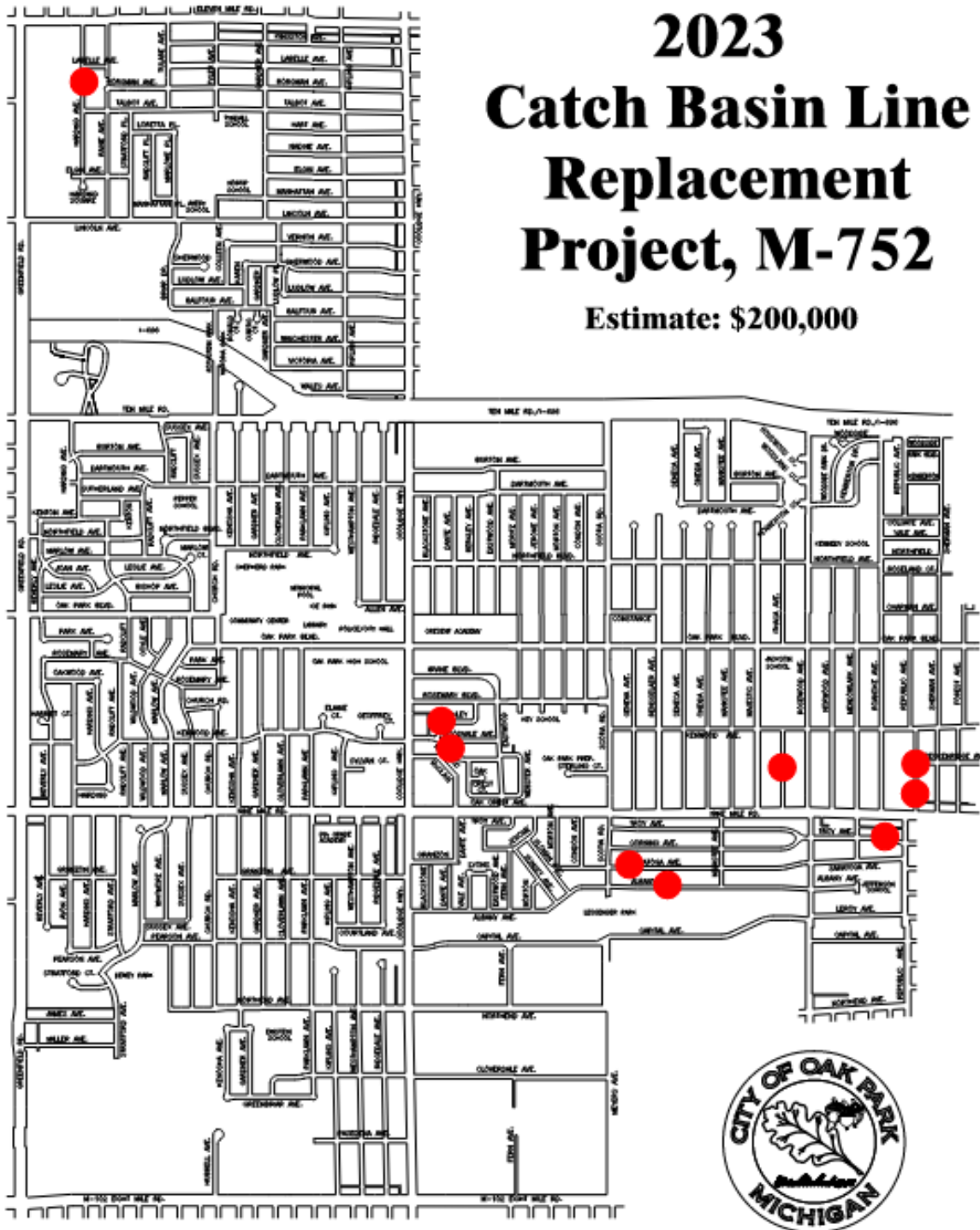
